The origins...

De Micco Metalli S.r.L. has been dealing for over twenty years with the transport, storage and recovery of ferrous and non-ferrous materials, in order to transform industrial processing waste into secondary raw materials to be reintroduced into the production cycle.

The turning point...

In 2015 the De Micco family, thanks to important economic investments, decided to expand the company by opening a new recovery plant in the industrial area of San Marco Evangelista (Ce). The storage site covers a total area of over 13,000 square meters of which approximately 5200 square meters are intended for storage and recovery and about 600 square meters are intended for the administrative offices of the company.




Our commercial numbers ...

(Total: about 27,000 tons)






Our turnover ...

Technical and organic equipment of personnel

For our services we use state-of-the-art equipment, roll-off bins, authorized vehicles, constantly checked to ensure quality and efficiency.

The De micco Metalli in its staff has about 30 employees including skilled workers, drivers, administrators and environmental engineers.

The company constantly invests in machinery and equipment, integrating new technologies in order to increase the productivity of the plants and the quality of their production, in fact De Micco Metalli has the following technological equipment attached to the production cycle:

- Compacting press model Taurus;
- ➤ Roll-off compacting press model BB44.D;
- ➤ Alligator shear;
- Cable stripper;
- ➤ Slow motion shredder and rotating blades model Marivan srl;
- ➤ Self-propelled crane loaders, forklifts and trucks.
- ➤ Panizzolo srl brand metal crusher with adjoining plant for separation and dust suppression of the latest technology;
- ➤ Roll-off containers and crates of various cubes;
- ➤ Container tipping station;
- ➤ Barriers for radiometric control of loads entering and / or leaving the plant, model Raycom srl.





































Investments made and planned
